Separate applications are invited for selection of Special Public Prosecutors(SPPs) for handling CBEC cases as well as NDPS cases before the District & Session Courts of Bettiah, Araria, Purnia, Katihar and Kishanganj pertaining to Commissionerate of Customs (P), Patna.

All aspiring advocates who have been in practice as an advocate for not less than 10 years & also qualify in terms of Section 24(8) of the Criminal Procedure Code, 1973 to the Bar council of the Patna High Court or Bar Associations of Subordinate Courts of Bettiah, Araria, Purnia, Katihar and Kishanganj and who are desirous to handle the CBEC cases on behalf of the Department may submit their application alongwith the Bio+Data in performa "A" to "the Legal Section, Office of the Commissioner of Customs(P), 5th Floor, Central Revenue Building, Birchand Patel Path, Patna-800001" by 18.11.2016. The proforma "A" can also be downloaded from departmental website customspatnazone.bih.nic.in. The advocate desiring to apply for selection of more than one Subordinate Courts/Courts of Session as mentioned above, needs to apply separately for each of such place.

The first engagement of an SPP shall normally be for a period of 18 months. Such engagement will be renewable on receipt of recommendation of the concerned Chief Commissioner alongwith the annual performance appraisal on completion first 12 months of the engagement.

The terms & condition of appointment (including fees and allowances) of SPPs for CBEC as contained vide CBEC (Legal Cell) letter No. 278A/82/2008-Legal dated 25.05.2010 or as revised has been placed on departmental website www.cbec.gov.in or customspatnazone.bih.nic.in and can be seen from there.
